

## Terms and Conditions

### Online quiz “Who could you be in national legends of Latvia and Russia?”

#### Organizer

Latvia-Russia Cross-Border Cooperation Programme 2014-2020 (hereinafter, the Programme)

#### Purpose

The Programme organizes the online quiz “Who could you be in national legends of Latvia and Russia?” (hereinafter, the quiz) as the initiative within the annual European Cooperation Day celebration. The quiz is of entertainment character and its purpose is to increase and inspire the interest of wider audience to the Programme participating regions – Latgale, Vidzeme, Zemgale, Riga, Pieriga, Pskov Region, Leningrad Region, St Petersburg – and to draw attention to the benefits that the Programme and projects bring to the Latvia and Russia border area. The quiz results by no means reflect the views of the Programme, Programme participating countries, Latvia and Russia, and Programme stakeholders. The results of the quiz serve only entertainment and outlook purposes.

#### Location

The quiz is available online on Online Test Pad platform: [www.onlinetestpad.com](http://www.onlinetestpad.com).

#### Duration

The quiz starts on **17 September 2020** and ends on **15 October 2020 or when all souvenirs are given away** (whatever happens earlier).

#### Who can participate

Any interested person from **16 years old**.

#### How to participate

To participate in the quiz a person answers the set of close-end questions. In the beginning, the participant can choose the language of the quiz (English, Latvian or Russian). Then the participant consequently answers the **set of 5 questions** by choosing one of proposed options. There are no correct or incorrect answers in the quiz. The quiz is deemed completed, when all the questions have been answered and result is demonstrated on the screen.

#### Souvenirs giveaway

Below the quiz result the participant is invited to take part in the souvenir giveaway. The Programme souvenirs will be given to the first 120 participants limited by 40 participants from Latvia, 40 participants from Russia (Pskov region) and 40 participants from Russia (St. Petersburg and Leningrad region).

To enter giveaway the participant enters his/her e-mail in the box below the quiz result. The persons among the first 120 participants of the quiz will receive the e-mail with information on where, when and how to receive the souvenirs. **The souvenirs should be received in the**

## **Programme office in Riga or branch offices in Pskov and St. Petersburg from 1 October 2020 until 15 December 2020.**

The souvenir kit includes environment friendly backpack and surprise item from the Programme.

### **Languages**

The quiz is available in national languages of participating countries – **Latvian** and **Russian** – as well as in working language of the Programme – **English**.

### **Data protection**

The data subject has given consent to the processing of his or her personal data. **A data subject accepts the “Terms and conditions” by entering email address to participate in the quiz souvenirs giveaway, where the following statement: “I give my consent to the processing of my personal data” and link to the “Terms and conditions” is provided.** The personal data of each participant will only be used for the purpose of organizing and managing this quiz and offering subscription to Programme news. The data will be stored electronically or in paper and will be used to inform the participant, who took part in the souvenir giveaway, about procedure of receiving the souvenir kit. The personal data will be stored until the end of the souvenir giveaway (18 December, 2020). Data processing is performed in accordance with requirements of the EU General Data Protection Regulation Nr.2016/679 of 27 April 2016.

A data subject has the right to request from the controller access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing and the right to data portability as well as to withdraw consent at any time. A data subject has the right to lodge a complaint with a supervisory authority: The Data State Inspectorate of the Republic of Latvia.
